Members will vote on the following issues:

1) Vote on a Dues Increase

The UFCW 1189 Executive Board met on September 19, 2023 to discuss the financial status of our union. The Executive Board recommends raising weekly dues by \$1.50 for all full-time members and \$1.00 for part-time members effective March 1 of each year for the next three years. This amounts to an increase of only about 4 cents per hour per member in each of the next three years.

The revenue increase will enable Local 1189 to:

- ✓ Maintain the size of our bargaining committees (Local 1189 pays time lost for all Union members serving on these committees)
- ✓ Continue and grow our strong Union Steward and Member Servicing Programs
- ✓ Continue to organize non-union workers and combat non-union competition that threatens the quality of our collective bargaining agreements.

The Executive Board would also like to set up a strike fund, so we are ready to take on Employers who are not willing to acknowledge your worth. At least 25 cents per member per week will be set aside from the dues increase to establish and grow this strike fund for years to come.

It is now up to our members to accept or reject this recommended revenue increase. We hope you will exercise your right to vote in authorizing this recommendation allowing for our Union to continue to take advantage of the opportunities of the current labor climate but to also be well-prepared for the challenges that employers will undoubtedly present to our members in the future.
