ARTICLE 28 TERM OF AGREEMENT

<u>Section 28.1</u> The parties agree that this Contract may be amended by mutual agreement of both parties, and if amended, the amendment shall be attached to the Contract by addendum and signed by both parties.

<u>Section 28.2</u> This Agreement shall be effective from the date hereof, except as otherwise specifically provided and shall continue in full force and effect through October 31, 2022 and shall continue from *year* to year thereafter unless either party serves notice in writing upon the other party ninety (90) days prior to the expiration date of its desire to terminate, modify or amend the provisions of this Agreement.

Effective November 1, 2020 and November 1, 2021 the parties agree that the only provision for negotiations shall be wages and no other provision of this Agreement will be impacted by the wage opener negotiations.
